Recent Results

- \$7,500,000 settlement for the family of a child born with cerebral palsy as a result of oxygen deprivation during labor
- \$8,300,000 against gynecologist and general surgeon for perforation of the large bowel during performance of a D&C, a 15-minute gynecological procedure, resulting in a coma and reconstructive surgeries
- \$7,500,000 against obstetrician for failure to perform a timely Caesarian section after failing to diagnose the mother's perforated uterus, leading to diagnosis of cerebral palsy and spastic quadriplegia in newborn
- \$5,000,000 against obstetrician and obstetrical nurse at hospital for failure to properly read fetal monitor strips, leading to hypoxia and cerebral palsy in newborn
- \$4,500,000 against both an obstetrician and a neonatologist for failure to diagnose fetal distress in a mother in labor, and then failing to properly resuscitate the newborn child, leading to the child's brain damage and cerebral palsy
- \$3,500,000 against family practitioner for failure to diagnose, by failing to properly take patient's blood pressure, malignant hypertension in the doctor's office, leading to severe vision loss of the patient
- \$3,500,000 against obstetrical nurse for failure to properly read the fetal monitor strip, leading to a delayed Caesarian section, causing brain damage and cerebral palsy in newborn
- \$3,350,000 against obstetrician and nurse for failure to diagnose fetal distress in a patient in labor. Both doctor and nurse misread the fetal monitor strip pattern, leading brain damage in newborn
- \$3,250,000 against laboratory for misreading two PAP smears, delaying the diagnosis of cervical cancer, leading to metastasis and patient's death
- \$3,200,000 against laboratory for misreading a PAP smear, delaying the diagnosis of cervical cancer, leading to her complete pelvic exenteration and metastatic cancer and ultimate death
- \$2,950,000 against laboratory and internist for failure to properly perform and then interpret a patient's PAP smear, delaying diagnosis of cervical cancer and causing her death
- \$2,500,000 against obstetrician and hospital for failure to diagnose fetal distress, losing the fetal monitor strips, delaying a Caesarian section, and resulting in brain damage and cerebral palsy to the child
- \$2,000,000 against neurosurgeon for failure to diagnose and treat a spinal cord injury with a back brace, resulting in additional partial paralysis
- \$2,000,000 against two nurse practitioners for failure to diagnose retinoblastoma, cancer of the retina, in a young child's eyes, resulting in metastatic disease and vision loss
- \$1,250,000 against obstetrician for failure to properly diagnose fetal distress in a mother in labor, and failure to properly read a fetal monitor strip, all causing brain damage and cerebral palsy in newborn
- \$1,210,000 against a tavern and social host for serving an intoxicated patron, and against the driver who negligently operated a car, which struck and fatally injured a pedestrian
- \$1,150,000 against a urologist for failure to diagnose urological cancer, leading to patient's death

- \$1,150,000 against chiropractor and neurologist for failure to diagnose a cervical herniated disc, a C4-5, resulting in paralysis to patient
- \$1,100,000 against a general practitioner and a physician's assistant for failure to diagnose a cerebral aneurysm, leading to a patient's stroke and partial paralysis
- \$1,100,000 against an internist for failure to recommend timely colorectal screening in a 55-year-old patient, leading to a delayed diagnosis of colon cancer and her death
- \$1,000,000 against a gynecologist for perforating a patient's colon during a D&C, resulting in a colostomy and reconstructive surgeries
