#### **Business Litigation/Real Estate Matters**

- Lead counsel for security/surveillance company in action alleging conspiracy to divert confidential information, customers, and business opportunities; negotiated favorable settlement.
- Represented major telecommunications carrier in a lease dispute where building owner alleged that the carrier's equipment caused property damage in excess of \$5 million dollars. Successfully negotiated a favorable settlement in which the carrier was not required to pay any money.
- Defended a mid-size plastic recycling company against breach of contract claims asserted by financial services company that had been retained to secure financing in excess of \$15 million dollars. Successfully dismissed all claims on summary judgment.

#### **Product Liability Defense**

- Obtained dismissal of all product liability claims against multi-national conglomerate by successfully convincing the court that our client did not manufacture the product (a concrete pump machine) and was not the "successor" of the actual manufacturer by way of "de facto" merger.
