Gilbert “Gil” Carey is an attorney and certified public accountant who practices in the areas of Taxation, Tax Resolution and Tax Controversy, and Estate Planning, solving tax, business, and legal challenges for individuals, privately held businesses and their owners.

Gil previously practiced law with prominent law firms in New York and Atlanta where he worked on estate planning and estate administration, tax litigation matters, and represented taxpayers in tax disputes with the IRS.

Immediately following law school, Gil was a personal law clerk to Hon. Lawrence E. Kahn, U.S. District Judge for the Northern District of New York.

In addition to his professional practice, Gil teaches and lectures on accounting, tax, and estate planning. He served as an Adjunct Professor of Law at Albany Law School in Albany, NY (2002 – 2017) and at the U.S. Army Judge Advocate General's Legal Center and School in Charlottesville, VA (2014 – 2017).

Gil is an Officer in the U.S. Army Reserve where he currently serves as a Rule of Law Team Chief for the 213th Legal operations Detachment. The Rule of Law Team provides guidance and legal counsel to commanders on the international legal framework for rule of law across the full spectrum of military operations – both along and beyond the conflict spectrum. The legal framework for rule of law operations includes United Nations Mandates, the Law of Armed Conflict, Treaty Law, Customary International Law, Occupation Law, and Human Rights Law.
