This is a remarkable achievement that speaks directly to her dedication to education and her passion for supporting schools in New Jersey," said Vito A. Wright served the Chester Board of Education as vice president from 2010-2012, as president from 2013-2015 and as chair of its Negotiations Committee for nearly 14 years. She was elected to the board in 2007 and is an NJSBA certified board member.

As the 2021-2022 winner, Wright will be recognized at Virtual Workshop 2021 and be featured in a future issue of School Leader magazine.
