He currently serves as Vice President of the New Jersey Association of School Attorneys, where he helps advance the profession statewide. He also is a sought-after speaker, having presented at the New Jersey School Boards Association's School Law Forum, the New Jersey School Boards Association's annual conference, the New Jersey Association of School Business Officials' annual conference, and before the New Jersey Superintendents' Study Council.
