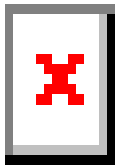


Porzio Promotes One Attorney to Principal and Four Attorneys to Counsel

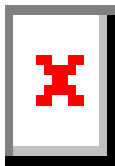

Sciences, LLC.

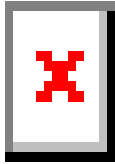

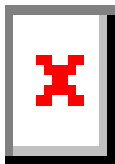

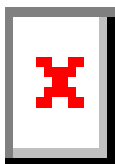
