AT A GLANCE

Bankruptcy: Successfully navigated a Chapter 11 bankruptcy for a family-owned safety and security systems business, addressing management changes due to the founder's brain cancer. The team's strategies, including a restraining order against competing former employees, led to a \$3.2 million asset sale, preserving jobs, operations, and creditor interests.

Corporate: Represented the seller in the sale of assets of a full-service market access marketing company in the healthcare industry to a portfolio company owned by a private equity firm. Porzio also represented the seller of a healthcare and clinical research organization to a portfolio company owned by a private equity firm.

Data Privacy: Continued practical counsel and guidance to emerging and well-established commercial enterprises on the principles and practices tailored to best position them to excel in the dynamic and increasingly specialized landscape of data governance regulation and enforcement.

Education: Oversaw the only three regional school district dissolutions in New Jersey history, resolving hundreds of employment issues successfully, and defeating all litigations challenging any aspect of the dissolution. Leading firm in representing schools serving special needs students.

Employment and Labor: Successfully represented New Jersey Chiefs of Police in an appeal affirming the constitutionality of *Daniel's Law*, which restricts the publishing of personal information about public officials.

This accolade recognized Porzio for becoming the first U.S. law firm to sell a technology subsidiary to private equity, setting a precedent in legal entrepreneurship.

Personal Injury & Med Mal: Achieved numerous favorable results, including a \$2.25 million mediated settlement against a gynecologist for the alleged delay in diagnosis of cervical cancer and a \$1.25 million mediated settlement for a pedestrian who was injured by a motor vehicle in a strip mall parking lot.

Real Estate, Land Use & Environmental: Obtained a favorable ruling in a quiet title action in Hudson County Superior Court against 13 defendants which allowed for the development of a state-of-the-art educational facility in Jersey City.

Advised owners of closely-held businesses, sold over a dozen private companies, and restructured others to save over \$50 million in taxes.
